Meeting Minutes

1. CCA Winter Conference

a. February 2-4, 2024, Sheraton Universal Hotel, Universal City, CA

2. Part-Time Faculty Forum Follow-up

- a. Wednesday, October 25th, Organized by PT Rep Greg Miraglia
- b. PT Rep Miraglia shared information about Part-Time Health Care
- c. CTA Rep joined to discuss CTA Member Benefits
- d. There is a NVCFA Session at Spring Flex Day Planned that will discuss this information as well.

3. Negotiations

- **a.** Load Proposals
 - i. Pres. Iwamoto shared situation concerning every FT instructor teaching at least one in-person or hybrid course per semester.
 - ii. "Right of Assignment" Clarification: District has the right to create as many sections of in-person/hybrid courses as they want, but assigning a certain number of those courses to Full-Time Faculty should be bargained
 - iii. VPAA has countered the proposal with expanded requirements that include FT Faculty working on campus three days a week (.4 minimum inperson load)
 - iv. Pres. Iwamoto countered 9/26/23 with a considerably lower threshold:
 - 1. Required 1 in-person/hybrid course maximum per Faculty (proportional for reduced load)
 - 2. Beginning in Fall 2024, .3 of assigned load in-person/hybrid modality. (No number of days of week required)
 - v. District countered 10/12/23 with new considerations:
 - 1. Required 1 in-person/hybrid course maximum
 - 2. Beginning in Fall 2024, .3 of assigned load in-person/hybrid modality. Faculty on reduced load will have .2 assigned load inperson/hybrid
 - 3. Faculty must be on campus at least 2 days per week.

- vi. Pres. Iwamoto will send a survey gauging membership feelings about the current District proposal. Here are the major sticking points that the survey will consider:
 - 1. Faculty required to work 2 days per week on campus
 - 2. Establishing a difference between "in-person" and "hybrid" courses in the way they each factor into in-person requirements.
 - 3. Reduced load pro-rating of in-person requirement (.2 vs .3)
- **b.** 2023-2024 Salary Reopener
 - i. There is no new information about salary negotiations as the District has cancelled the two previous negotiating sessions.
