Meeting Minutes

1. CTA Issue

- a. Ann Swinburn visited to discuss the Mayacamas Charter School issue happening in Napa County, and how it intersects with CTA/CCA concerns.
- b. Swinburn asked NVCFA for support in opposing charter. She asked membership to sign a petition indicating their support for opposition.

2. CCA Fall Conference

a. October 13-15 at Hyatt Regency SF, please email Pres. Iwamoto if any member is interested in attending.

3. Negotiations

- **a.** Load Proposals
 - i. Pres. Iwamoto shared situation concerning every FT instructor teaching at least one in-person or hybrid course per semester.
 - ii. VPAA has countered the proposal with expanded requirements that include FT Faculty working on campus three days a week (.4 minimum inperson load)
 - iii. Pres. Iwamoto indicated NVCFA is not agreed on this proposal, and will continue negotiating a solution to this requirement.
- **b.** 2023-2024 Salary Reopener
 - i. Lead Neg. Quinlan reported on the salary negotiations.
 - ii. Due to increased Property Tax, NVCFA and the District are reopening negotiations for this year's salary increase, but the base increase will be 8% (MOU signed to increase by 8% already)
 - iii. Opening offer from NVCFA is 14% (8% already guaranteed + 6% more) including adding Family Benefits paid by District
 - 1. This is based partially on Solano Comm. College Faculty receiving 14% salary increase.
 - iv. District will respond by the end of the month
 - v. Treas. Gianvecchio presented on history of salary negotiations in order to contextualize current salary situation and future goals of NVCFA

- vi. There were questions and concerns regarding the addition of Family Benefits and whether or not that was a likelihood.
- c. Part-Time Health Benefits
 - i. State budgeted \$200M toward reimbursing Part-Time Benefits
 - ii. We were told we couldn't access this money because we are in CalPERS
 - 1. Negotiations are ongoing to correct this issue because it now seems to be possible for Part-Time Benefits to be funded by State.
